FOREWORD

In what has been a tumultuous time for everyone, I am particularly proud that the BMA was able to host this year's International Conference on Physician Health (ICPH), organised jointly with the American and Canadian Medical Associations. The conference – with a theme of 'A vision for humanity in medicine' – could not have happened at a more crucial time for the profession, as doctors around the world continue to struggle on the frontlines of a truly international effort to contain and overcome the COVID-19 pandemic.

This global public health emergency has tested and heaped pressure on the physical and mental health of doctors working in every medical specialty, and in every corner of all healthcare systems, the world over.

Doctors across the globe are exhausted from the relentless and intense workload they have endured for more than a year. They have experienced significant changes to their working lives and managed the emotional effect of the risk to not only their own health but of their loved ones. Keynote sessions included exploring the effect of the COVID-19 pandemic on doctors' health and wellbeing as well as on physician health services, peer support, work-life balance, and avoiding burnout.

Special thanks go to Professor Debbie Cohen and the abstract review committee for helping to select the excellent programme, and to our expert group who in the early planning stages identified our pertinent conference theme as well as some of our keynote speakers.

Finally, I would like to thank everyone involved with putting this conference together, including the ICPH planning committee, the BMA conference unit, wellbeing team, AV team, and field events team, and all the other staff who kindly participated as session moderators. Thank you also to our supporters and contributors.




EVENT OVERVIEW

In April, the BMA hosted the International Conference on Physician Health (ICPH), held virtually for the first time and attended by over 750 delegates from around the world. Jointly organised with the American and Canadian Medical Associations, this biennial conference provides a platform for physicians and other health community leaders to learn, connect, and develop strategies and networks to support each other.

This year's event, spread over five afternoons instead of the usual three days, was scheduled to be face-to-face in London in September 2020 but was rescheduled to run virtually in April 2021. Themed 'A vision for humanity in medicine', the conference invited experts and practitioners from around the world, who are passionate about physician wellbeing, to share their learnings, experiences, and ideas from what has been an unprecedented year.

Attendees and countries represented

Without the constraints of travel or a venue's space limitations, ICPH 2021 attracted over 750 participants compared to 305 when the BMA last hosted ICPH in 2014. This year's delegates represented 15 countries across five continents, including: Australia, Belgium, Canada, Finland, Germany, Ireland, Israel, Malta, Netherlands, New Zealand, Norway, Spain, UK, USA and Uruguay.

The planning committee consisted of representatives from the British, Canadian, American and Australian Medical Associations.

 Colin West to hear key learnings from COVID-19 for physician wellbeing from
 across the globe.
- Thursday: Dame Clare Gerada discussed preventing physician suicide with powerful and moving stories from members of her bereavement group.
- Friday: Lastly, we heard some insights into the life of an NHS junior doctor from Adam Kay.

In addition to these insightful keynote sessions, the varied oral presentations, workshops, and posters explored important themes including:


- The psychological impact of COVID-19 on physician wellbeing
- Preventing burnout
- System-level interventions
- The gender gap.

They also helped our delegates to build a rounded set of skills that are beneficial to one's wellbeing.

Presentation and workshop content for the programme was curated by an abstract review committee chaired by Professor Debbie Cohen. They reviewed over 700 abstracts, including the additional 50 abstracts we received following a late call specifically on the topic of COVID-19. From this, the abstract review committee selected 60 themed oral presentations, 19 interactive workshops and 53 poster presentations.

Content was also available on demand for 12 weeks following the event to allow participants to make the most of the excellent programme, particularly helpful for those based in different time zones.
